Dear Senator Murray:

I am writing to provide notification of the Department of Health and Human Services' (HHS) plans to reallocate up to \$266 million in Fiscal Year (FY) 2018 funding for the Unaccompanied Alien Children program.

The number of unaccompanied alien children in HHS custody has increased steadily, and existing shelter capacity is nearly full. HHS is closely monitoring shelter capacity needs, and is in communication with our interagency partners. Based on this growth pattern, and an increased length of time needed to safely release unaccompanied alien children to sponsors, HHS is preparing for the trend of high capacity to continue.

As a result, I plan to use my Secretarial transfer authority to reallocate up to \$186 million in FY 2018 funds from other FY 2018 HHS resources, and to reallocate up to \$80 million from refugee programs within the Office of Refugee Resettlement so that it can increase shelter capacity and meet its statutory duty to provide shelter to all unaccompanied alien children referred to HHS for care.

I appreciate your continued interest and support of these activities. I am sending identical letters to Senator Roy Blunt and Representatives Tom Cole and Rosa DeLauro.
