Dear Mr. Secretary:

We are writing to insist on full compliance with the Committee's previous requests for documents from the Department of Health and Human Services (HHS) relating to the preparation for and response to Hurricanes Irma and Maria in Puerto Rico and the U.S. Virgin Islands.

On October 11, 2017, then-Chairman Trey Gowdy and then-Ranking Member Cummings sent a bipartisan letter to Acting Secretary Don Wright, requesting the following documents:

- 1. Documents or communications received, prepared, or sent before September 5, 2017, by officials of the Department of Health and Human Services or any of its offices or divisions, relating to threat assessments, mitigation measures, emergency preparedness, or other contingency plans in the case of a hurricane striking Puerto Rico or the U.S. Virgin Islands; and
- 2. Documents or communications received, prepared, or sent between September 5, 2017, and October 4, 2017, by officials of the Department of Health and Human Services or any of its offices or divisions, relating to any steps taken to prepare Puerto Rico and the U.S. Virgin Islands for Hurricanes Irma and Maria, as well as logistics challenges, distribution of commodities, or power restoration following the storms.¹

On December 19, 2018, as incoming Chairman of the Committee, Rep. Cummings sent a follow-up letter requesting full compliance with the October 2017 document request by January

11, 2019.² On December 28, 2018, HHS informed the Democratic staff that the letters had been received and that "responses should be turned around shortly."³ Since then, the Committee has not received any additional documents from the Department.

Please produce all responsive documents by May 20, 2019. If all responsive documents are not produced by this date, the Committee will consider alternative means to obtain compliance.

The Committee on Oversight and Reform is the principal oversight committee of the House of Representatives and has broad authority to investigate "any matter" at "any time" under House Rule X.

Responding to Oversight Committee Document Requests

- 1. In complying with this request, produce all responsive documents that are in your possession, custody, or control, whether held by you or your past or present agents, employees, and representatives acting on your behalf. Produce all documents that you have a legal right to obtain, that you have a right to copy, or to which you have access, as well as documents that you have placed in the temporary possession, custody, or control of any third party.
- 2. Requested documents, and all documents reasonably related to the requested documents, should not be destroyed, altered, removed, transferred, or otherwise made inaccessible to the Committee.
- 3. In the event that any entity, organization, or individual denoted in this request is or has been known by any name other than that herein denoted, the request shall be read also to include that alternative identification.
- 4. The Committee's preference is to receive documents in electronic form (i.e., CD, memory stick, thumb drive, or secure file transfer) in lieu of paper productions.
- 5. Documents produced in electronic format should be organized, identified, and indexed electronically.

We are writing to insist on full compliance with the Committee's previous requests for documents from the Federal Emergency Management Agency (FEMA) relating to the preparation for and response to Hurricanes Irma and Maria in Puerto Rico and the U.S. Virgin Islands.

On October 11, 2017, then-Chairman Trey Gowdy and then-Ranking Member Elijah Cummings sent a bipartisan letter to then-Acting Secretary of Homeland Security Elaine Duke requesting the following documents:

Documents or communications received, prepared, or sent before September 5, 2017, by officials of the Department of Homeland Security or any of its components, offices, or directorates, including FEMA, relating to threat assessments, mitigation measures, emergency preparedness, or other contingency plans in the case of a hurricane striking Puerto Rico or the U.S. Virgin Islands; and
- 2. Documents or communications received, prepared, or sent between September 5, 2017, and October 4, 2017, by officials of the Department of Homeland Security or any of its components, offices, or directorates, including FEMA, relating to any steps taken to prepare Puerto Rico and the U.S. Virgin Islands for Hurricanes Irma and Maria, as well as logistics challenges, distribution of commodities, or power restoration following the storms.¹

FEMA failed to produce key documents responsive to that request despite multiple, repeated inquiries by Committee staff.

On December 14, 2018, after the midterm elections, Rep. Cummings sent a letter requesting that you "fully comply, by December 31, 2018," with the previous bipartisan request and explained in detail how FEMA's previous productions were "obviously incomplete."²

Since then, FEMA has not produced any additional documents responsive to the October 2017 bipartisan document request.

We are now writing to insist that you fully comply with this bipartisan request that was made more than 18 months ago. We ask that FEMA prioritize production of the following documents:

- 1. All documents and communications regarding FEMA's contract with Tribute Contracting LLC to provide meals in Puerto Rico (Solicitation Number: HSFE70-17-R-MARIAMEALS), including:
 - a. the complete file of the contracting officer on the award and administration of the contract;
 - b. all bids submitted for the contract; and
 - c. all communications relating to the contract, including FEMA communications with the Department of Homeland Security, with Tribute Contracting LLC, or with others outside the Department;
- 2. All documents relating to any other contracts (including modifications) that have been cancelled or terminated, or that have been or are currently in default, relating to Hurricanes Irma and Maria in Puerto Rico and the U.S. Virgin Islands;
- 3. All documents and communications regarding mass graves found in Puerto Rico, including all documents and communications referring or relating to a September 29, 2017, email exchange from the Department of Defense reporting the discovery of mass graves in Puerto Rico; and
- 4. All communications referring or relating to Hurricanes Irma and Maria that involve then-Administrator Long or other senior FEMA officials, senior officials at the Department of Homeland Security and its components, senior officials from other federal agencies, and White House officials.

- 7. The term "related to" or "referring or relating to," with respect to any given subject, means anything that constitutes, contains, embodies, reflects, identifies, states, refers to, deals with, or is pertinent to that subject in any manner whatsoever.
- 8. The term "employee" means any past or present agent, borrowed employee, casual employee, consultant, contractor, de facto employee, detailee, fellow, independent contractor, intern, joint adventurer, loaned employee, officer, part-time employee, permanent employee, provisional employee, special government employee, subcontractor, or any other type of service provider.
- 9. The term "individual" means all natural persons and all persons or entities acting on their behalf.

Dear Mr. Mulvaney:

For the past two years, the White House has refused to produce to the Committee any documents regarding the Trump Administration's abominable response to Hurricanes Irma and Maria in Puerto Rico and the U.S. Virgin Islands. The White House was able to evade all oversight and accountability during this period because the Republicans who led the Committee refused to join Democrats in sending even one request for documents.

Despite the Oversight Committee's bipartisan history under Republican Chairman Tom Davis of obtaining tens of thousands of documents from the Bush White House after Hurricane Katrina, Republicans actively blocked all Democratic requests over the past two years while President Trump heaped scorn on the very people who lost thousands of their loved ones.

This refusal to conduct credible and bipartisan oversight was a betrayal of our fellow American citizens in Puerto Rico and the U.S. Virgin Islands, and it was a dangerous failure to learn from the mistakes of the past to prevent them from happening again in the future. The American people—regardless of where they live—expect their government to work as effectively and efficiently as possible, especially in times of disaster.

Today, the Oversight Committee is reestablishing its investigation of the Trump Administration's response to the hurricanes in Puerto Rico and the U.S. Virgin Islands—and the White House will not be exempt. The purpose of the investigation is to determine whether any of our nation's disaster response laws need to be amended and improved—including with respect to long-term planning, advance contracting, real-time communications, intelligence-sharing, and leadership structure.

Background

On October 11, 2017, then-Ranking Member Cummings sent a letter to then-White House Chief of Staff John Kelly requesting the following documents:

- 1. Documents and communications received, prepared, or sent before September 5, 2017, by officials of the White House or any of its components, offices, or directorates, relating to threat assessments, mitigation measures, emergency preparedness, or other contingency plans in the case of a hurricane striking Puerto Rico or the U.S. Virgin Islands; and
- 2. Documents or communications received, prepared, or sent between September 5, 2017, and October 4, 2017, by officials of the White House or any of its components, offices, or directorates, relating to any steps taken to prepare Puerto Rico and the U.S. Virgin Islands for Hurricanes Irma and Maria, as well as logistics challenges, distribution of commodities, or power restoration following the storms.¹

This request tracked closely a similar request in 2005 that was sent by then-Chairman Tom Davis to the White House seeking documents relating to Hurricane Katrina. In response to Chairman Davis' requests, the George W. Bush White House produced "more than 12,000 pages of documents from the Executive Office of the President" and "almost 6,000 pages of documents" from the Office of the Vice President.²

Although Ranking Member Cummings' request followed Chairman Davis' bipartisan precedent of requesting documents from the White House regarding natural disaster response efforts, Rep. Trey Gowdy, then the Chairman of the Committee, refused to join this request.³ The White House did not respond to Ranking Member Cummings' request or produce any of the requested documents.

On October 26, 2017, Ranking Member Cummings wrote a letter to Chairman Gowdy requesting that Committee Members be allowed to debate and vote on a motion to issue a subpoena for these documents.⁴ Chairman Gowdy declined again.

On October 31, 2017, Ranking Member Cummings sent a letter on behalf of all Democratic Committee Members asking Chairman Gowdy to allow the Committee, at its upcoming business meeting on November 2, 2017, to vote on the issuance of subpoenas, including one to the White House for documents relating to the response to the hurricanes in Puerto Rico and the U.S. Virgin Islands.⁵ Rep. Gowdy declined.

During the business meeting on November 2, 2017, Democratic Members attempted to move to issue these subpoenas, but Republicans blocked their attempts to do so.⁶

Nearly a year later, on September 6, 2018, Ranking Member Cummings issued a staff report entitled, "A Failure of Oversight: How Republicans Blocked a Credible Investigation of the Trump Administration's Response to the 2017 Hurricanes." That report described significant evidence of waste, fraud, and abuse collected by Democratic investigators. However, it also highlighted the limitations of inadequate access to documents and testimony necessary to conduct a thorough investigation.⁷

On September 13, 2018, Ranking Member Cummings wrote to Chairman Gowdy again to ask that he "join me in finally sending a request to the White House to produce documents relating to the Trump Administration's response to the hurricanes last year in Puerto Rico and the U.S. Virgin Islands, which killed nearly 3,000 Americans."⁸ Chairman Gowdy refused.

As a result, the White House has never turned over a single piece of paper to the Committee over the past two years relating to its response to the hurricanes in Puerto Rico and the U.S. Virgin Islands.

Request for Documents

For these reasons, the Committee now requests that the White House produce by May 20, 2019, all of the documents requested by Ranking Member Cummings on October 11, 2017. If you continue to withhold these documents from the Committee, the Committee may be forced to consider alternative means to obtain compliance.

The Committee on Oversight and Reform is the principal oversight committee of the House of Representatives and has broad authority to investigate "any matter" at "any time" under House Rule X. In addition, House Rule X, clause 3(i) specifically charges the Committee with conducting oversight of "the operation of Government activities at all levels, including the Executive Office of the President."


